壹	前言	I. Introduction		
1	中華民國(臺灣)立法院於2014年6月通過《兒童權利公約施行法》(下稱《CRC施行法》),並於同年11月20日開始施行,作為《CRC》在臺灣實施之國內法化架構;2016年4月22日立法院通過加入《CRC》條約案,總統於2016年5月簽署加入書。	In June 2014, the Legislative Yuan of the Republic of China (Taiwan) passed the Implementation Act of the Convention on the Rights of the Child ('Implementation Act'). The Act came into force on 20 November 2014 and provides the framework for domestic harmonization of the CRC. On 22 April 2016 Taiwan's Legislative Yuan passed a Bill to support the adoption of the CRC paving the way for the President to sign the Instrument of Accession to the CRC in May 2016.
